WESTERNIZATION REPORT 2024



The StrategEast Westernization Report 2024 offers a comprehensive snapshot of the progress of Westernization in post-Soviet Eurasia. The report features analysis from experts across Eurasian and Baltic countries, detailing significant political and economic events of the past year that have shaped the region. Over the past four years, the report has become an essential resource for international financial institutions, development agencies, governments, and think tanks in Eurasia and the

West. This report identifies the key events and trends impacting the degree of Westernization in the countries that gained or restored their independence after the Soviet Union's collapse. Last year, the paradoxical leader in Westernization process was Ukraine, which, despite facing severe trials, has emerged as a beacon of Westernization. In the midst of war, Ukraine has seen unprecedented Western support, including its nomination as a candidate for EU membership. Meanwhile, Russia's fullscale invasion in 2022 has turned Eurasia into a geopolitical and economic battleground, pitting Russia and China against Western efforts. The United States and the European Union have focused on two primary objectives in the region. First, protecting nations from Moscow's influence by enhancing political and economic cooperation. And second, preventing Russia from exploiting the region as a gray zone to bypass sanctions, acquire military components, or evade banking restrictions. In 2023, Western powers largely adopted policies of encouragement, fostering cooperation rather than imposing punitive measures. However, in 2024, the US began targeting specific companies in Armenia and Kyrgyzstan with sanctions for alleged involvement in gray supply chains supporting Russia's military-industrial complex. Central Asia is navigating a complex geopolitical landscape, balancing growing economic ties with China while exploring multifaceted partnerships with the West. Formats like the "C5+1" with the US and the "EU-Central Asia" summit signal promising avenues for regional cooperation. These initiatives aim to offer an alternative to over-dependence on China, which has been providing loans, investments, and even military guarantees.

The report also highlights countries with less visible consequences of recent global events, noting that the impact on their Westernization will become clearer in the 2025 edition of the report. The StrategEast Westernization Report 2024 remains a critical tool for understanding the shifting dynamics in Eurasia as the region grapples with the forces of Westernization, Russian influence, and rising Chinese engagement.

on September 17-18 in strategic collaboration with Tekwill, Moldova's premier networking facilitator in the tech ecosystem, along with Invest Moldova, Moldova Innovation Technology Park, and ABSL Moldova. Supported by USAID and Orange Moldova, this edition of the Forum was a key event within Moldova Business Week 2024.

With the lead topic on Trustworthy AI for Sustainable Economy, the event was organized with the support of USAID, DAAC Digital, EBRD, the World Bank, Tekwill, InvestMoldova, ABSL Moldova, Sigma Software, High Technology Park of the Kyrgyz Republic.

The event featured over 40 speakers including Dorin Recean, Prime Minister of Moldova; Dumitru Alaiba, Deputy Prime Minister and Minister of Economic Development and Digitalization of Moldova; and the greatest tech minds and more than 150 participants, who delved into key topics like talent retention, trust in AI, and opportunities for global IT companies in the region.

Cezara Panait, Head of Government Affairs & Public Policy, Google Romania, Bulgaria and Moldova:

"Al has tremendous potential to advance societal good, whether in education, work, healthcare, or climate action. We're now generally just scratching the surface of what this technology can achieve. But it's crucial to also understand its challenges and risks.

In Romania, we partnered with the Ministry of Environment to implement cloud AI solutions that monitor illegal deforestation. Foresters are required to take photos of logging activities and upload them for verification, but the manual review process was overwhelming for the Ministry. By using AI, we automated the verification, which allowed for faster, more accurate oversight, and prevented manipulation, such as submitting photos of old or unrelated logging. This initiative has resulted in fines of 700,000 euros and has protected a significant number of trees, showcasing how AI can be used effectively to combat illegal deforestation and promote sustainable practices."

"We are still in the stage where Al acts as a copilot—assisting tasks but not yet autonomous. To really harness its potential, both private companies and governments need to collaborate, ensuring that Al doesn't just augment the world, but also preserves human agency.

The future of AI depends on cooperation between government, big tech, and civil society. This collaboration is essential to ensure AI is deployed responsibly and ethically, benefiting all sectors of society."

Irina Buzu, Advisor to the Deputy Prime-Minister, Minister for Economic Development and Digitalisation of Moldova:

"Trustworthiness in AI requires clear boundaries between human and machine. When we blur the line between what is human and what is technological, it becomes harder to build trust. We need to invest in people to enhance our human experiences and foster trust in AI.

Collaboration has made everything possible so far—from developing a widely accepted definition of AI to building Moldova's AI ecosystem. Networking, sharing experiences, and aligning with regional efforts have given me optimism that we're moving in the right direction."

Amir Hegazi, Managing Director of Capital Democracy:

"In emerging markets like Eurasia, you need a minimum viable ecosystem. This means removing regulatory bottlenecks that deter founders from starting or staying local and that prevent investors from entering the market. It's not just about capital; it's about creating the right environment with clear regulations, strong education, and community support to help startups thrive. In Saudi Arabia, simplifying processes, removing red tape—such as enabling company registration in a day or a few days not weeks or months—unlocked massive potential. Eurasia can achieve the same by eliminating regulatory hurdles."































Policy Recommendations based on Forum 2024

- 1. The successful implementation of AI in digital transformation will enable Eurasian governments to address complex challenges, such as improving healthcare, modernizing infrastructure, enhancing public safety, and driving innovation.
- 2. Each Eurasian country should develop a comprehensive Al strategy that aligns with its broader digital transformation goals.
- 3. Eurasian countries should establish ethical and legal standards: develop Al legislation based on international best practices, ensuring the protection of human rights, privacy, and security.
- 4. International financial institutions and development agencies should support small and medium-sized enterprises in adopting Al as part of their digital transformation by offering targeted training and financial assistance.

- To combat brain drain and retain top talent, Eurasian countries must prioritize the development of their IT industry by creating a dynamic and innovative ecosystem that offers competitive opportunities for local professionals.
- Central Asian countries have made significant strides in developing their legal frameworks and IT ecosystems, making them an attractive and trusted destination for the global tech industry.
- 7. Moldova has the potential to become a key hub for Eurasian countries, acting as a bridge between the West and Eurasia in the development of the IT industry, attracting investment, and integrating IT ecosystems.
- 8. Ukraine, with its strong IT foundation, has the potential to lead in AI development.
- 9. A key aspect of advancing AI across these countries is the exchange of knowledge.

StrategEast facilitated trade mission connecting Eurasian tech companies to Qatari business community



In cooperation with the office of the Commercial Attaché of the State of Qatar in the US, StrategEast organized a trade mission to Doha, Qatar, on February 14-15, 2024 bringing together C-level executives from leading global engineering companies with substantial operations in Eurasia. Notable participants included AltexSoft, Computools, Eleks, EPAM, Global Logic, Intellias, Lineate, Nix, Sigma Software, and Tripmaker. The primary objective of the mission was to introduce these IT companies to Qatar's business community in order to explore collaboration opportunities, shedding light on Qatar's tax incentives, and fostering strategic matchmaking meetings with influential stakeholders. These series of events created multiple business opportunities for the participants on both sides.

StrategEast organized visit of Ukrainian IT leaders to Washington



On April 16-18, 2024 StrategEast coordinated a visit by a Ukrainian business delegation to Washington, aimed at forging working relationships with state institutions, gaining insights into their operational principles and exploring avenues for collaboration with prominent US businesses.

The delegation included top managers from Ukraine's leading IT companies, such as AltexSoft, Deus Robotics, Eleks, Exadel, Intellias, MacPaw, Roosh, Sigma Software Group and SoftServe.

The Ministry of Digital Transformation of Ukraine joints efforts with StrategEast to develop digital bridge between Ukraine and the Gulf



From April 21 to May 1, 2024 Ukraine's Ministry of Digital Transformation in collaboration with StrategEast held a series of high-level meetings to foster collaboration at both governmental and business levels within the Gulf region.

Sergey graduated from Moscow University for the Humanities with a degree in Management. He also studied at the University of Malta.




Valery Vavilov
